Art Academy of Cincinnati / Memphis College of Art Transfer Admission Guarantee

This document establishes a transfer admission guarantee between the Memphis College of Art and the Art Academy of Cincinnati. In entering this agreement, the Memphis College of Art and the Art Academy of Cincinnati acknowledge the goal of both institutions to minimize barriers to transfer and to increase the number of students who successfully complete the Baccalaureate degree. This agreement assures Memphis College of Art students that they will be granted admission to the Art Academy of Cincinnati's Bachelor of Fine Arts degree program if they follow the terms of the approved transfer agreement.

I. General Provisions of this Guarantee

The following information outlines the admission guarantee between the Art Academy of Cincinnati and the Memphis College of Art.


- 1.1 This Transfer Admission Guarantee will be in effect for the Spring Semester of 2018 and will continue through the 2017 – 2018 academic year and the 2018 – 2019 academic year.
- 1.2 Memphis College of Art students who are in good standing are guaranteed admission to the Art Academy of Cincinnati's BFA degree program provided that:
 - 1.2.1 the courses transferred fulfill requirements for the BFA in one of the majors offered by the Art Academy of Cincinnati,
 - 1.2.2 the student, at the time of application for transfer, has a cumulative grade point average of 2.0 or higher,
 - 1.2.3 only courses completed and passed at Memphis College of Art are eligible for transfer under this agreement.
- 1.3 This guarantee assures Memphis College of Art students of admission to the Art Academy of Cincinnati in the Bachelor of Fine Arts degree program only.
- 1.4 Either institution may terminate this agreement for any reason by providing written notice to the other institution by August 1st of the academic year in which the transfer agreement shall terminate. Any Memphis College of Art student enrolled under this agreement as of the August 1st termination notice will have the agreement remain in force as long as the student remains continuously enrolled at Memphis College of Art. No Memphis of Art student may enroll under this agreement after the termination notice date.

II. Conditions of the Guarantee

To qualify for the Transfer Admission Guarantee, students enrolled at Memphis College of Art must submit an undergraduate application for admission to the Art Academy of Cincinnati's BFA degree program.

III. Evaluation and Review

The Art Academy of Cincinnati and the Memphis College of Art agree to review this agreement at the conclusion of the 2018 – 2019 academic year. Memphis College of Art and the Art Academy of Cincinnati will each designate an individual to serve as liaison for the purposes of monitoring this agreement. Each institution will provide updated catalogs to the other upon request. If requested by Memphis College of Art, the Art Academy of Cincinnati agrees to provide to Memphis College of Art reports on Memphis College of Art transfer students enrolled in the Art Academy of Cincinnati's BFA degree program; their majors, and academic performance to the extent permitted by law.
